TERMS AND CONDITIONS OF THE TENDER .

1. INTRODUCTION: Traco Cable Company, is a Kerala Government Company, engaged in the manufacture of Cables, Conductors and Wires, having three factories at Irimpanam (Tripunithura) , Chumathra (Thiruvalla) and Padannakkara (Thalassery) .
2. SUBMISSION OF TENDER: Tenders must be submitted in sealed cover.
3. PRICE: Firm Price should be quoted in Price bid mentioned in Annexure -A.
4. Tax: Service tax / Sales tax if leviable and claimed should be clearly mentioned in the price bid and bills. All the taxes, including taxes imposed by local bodies / authorities are to be born by the contractor.
5. SPECIFICATION: All the painting works should be done with Asian Paints only. Contract for all the works are valid for a period of one year from the date of satisfactory completion of each work. Quality of all the works should be maintained for a period of one year from the date of completion of work for each items.
6. TRACO CABLE CO LTD shall have the right to reject any tender or part thereof or all the tenders without assigning any reason whatsoever. Assignment of contracts and or subletting of this contract either in whole or in part are strictly prohibited.
7. VALIDITY OF THE TENDER: All tenders must remain open for acceptance for 30 (thirty) days from the date of opening the tender.
8. DELIVERY: The work should be completed at all destination within 60 days form the date of receipt of the work order in all respect.
9. INSPECTION: The Company's Competent Authority or any other person duly authorized by him shall inspect the quality of work executed. Defectives, not conforming to the specification mentioned if any will have to be rectified as per specification, by the contractor at their own risk and cost within one week on receipt of intimation.
10. PAYMENT TERMS: 85 % of the contract value will be released after successful completion of the work and balance 15 % will be paid after successful completion of the contact period of one year. Part payment is allowed as and when each work is completed.
11. ARBITRATION: All disputes and difference except the matters decision whereof are specifically provided for under the terms and conditions of this tender shall be referred to the Arbitration of the Managing Director of the company or his nominee whose decision shall be final and conclusive under the provisions of the Indian Arbitration Act 1940 and the Rules there under the statutory modification thereof, if any, shall be deemed to apply. If however, no award can be made by the Arbitrator within a period of four months from the date of entering on the reference by him the Arbitrator may enlarge time for making the award with the consent of all the parties to the Arbitration proceeding. All quotations and contracts under this tender are subject to jurisdiction of the appropriate local Court of Ernakulam.
12. The authority to take the final decision of the tenders received with fully rest with the Management of this Company and whatever decision is taken by the Management of this Company will be valid and binding on all

tenders. All questions disputes arising under out of or in connection with this tender shall be decided by the Managing Director of the company, whose decision shall be final and binding on the tender.

13. In the event of the contractor indulging in any malpractice or fraud in executing the work as per this tender and the contract, TRACO CABLE CO. will have the right to cancel the contract and black list the contractor.
